1. Introduction

This website is operated by **Logiciel OddsJuice Inc** (“**Company**”, “**we**”, “**our**”, “**us**”). Logiciel OddsJuice Inc offers this website, including all information, tools and Services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.
